WILDLIFE CONSERVATION PROGRAM:

"Big Tusker Project"- aerial and ground mobile teams:

Tsavo Trust's Big Tusker Project (BTP) recorded the following details in the BTP database:

- Total of 17 different individual Tusker's were observed from ground and air coverage.
- 5 bull Super Tuskers 11 different sightings.
- 9 Emerging bull Tuskers 15 sightings.
- 3 Iconic cow Tusker 4 sightings.
- ➤ Total sightings 30
- ➤ Weather conditions: TT HQ rainfall: 8mm. Total rainfall at Tsavo Trust HQ to date: 12.5mm.
- ➤ Elephant mortality: 8 carcasses located (6 fresh, 2 old): C of D 2 poached, 3 natural, 3 unconfirmed.
- ➤ *Rhino security:* Regular aerial recces with KWS over TWNP & TENP rhino areas in partnership with ZSL. 11 rhino specific air recces resulted in 3,855km flown over 31.1 hrs (9 TW & 2 TE).
- ➤ Collared Elephant: Ongoing 25 observations (ground and air) by joint KWS / TT teams.
- > TCA Carnivore Census: Tsavo Trust Tembo 2 & 4 monitoring teams supporting the KWS led TCA Carnivore Census, completed end April.
- > Critically Endangered Raptor monitoring: Ongoing


Photo of Super Tusker coded as LU1 in April 2019.

Aerial Reconnaissance - Areas Covered:

- This vital conservation tool provides "eyes in the skies" over Tsavo and directional guidance to ground units.
- All flight paths are logged and recorded with all relevant real-time observations relayed to KWS on a daily basis for their records as well as necessary rapid reaction.

Map below shows Tsavo Trust's flight paths over the TCA in April 2019. 75 hours flown covering 8,716 kilometers over Tsavo in support of KWS: Air & ground activities; Big Tusker monitoring; Locating illegal activities; Wildlife monitoring; Aerial census and tracking.



Aerial photo of a poachers shooting platform in the top of a high bush overlooking a water hole in the remote northern area of TENP sighted on 9th April 2014.

Poachers using poisoned arrows perch on these platforms so as to get a safe and tactical high point overview of wildlife (particularly elephants) coming into drink so that they can arrow them from close range.



Photo below shows a newly born baby rhino calf in TWNP – IPZ on 28th April 2019.



Photo taken on south boundary of TENP on 28^{th} April 2019 showing illegal cattle blatantly grazing near several herds of elephants that remained clumped together – a clear sign of their stress.



Field Mobile Units:

Tsavo Trust's mobile field teams work alongside KWS, who take the lead role, on a daily basis. *Tembo 1, 3, 5 teams & Kamungi Scouts* are habitat protection / de-snaring focused whilst *Tembo 2 & 4 teams* are wildlife monitoring based. All teams provide further "eyes and ears on the ground".

COMMUNITY CONSERVANCY PROGRAM:



- ✓ Ongoing partnership between Tsavo Trust and Kamungi Conservancy (KC) (bordering northern boundary of TWNP Triangle). KC is located in Makueni County; Kibwezi Sub county; Mtito Andei Division; Mtito Andei Sub-location; Ngiluni Village.
- ✓ *Employment:* Between Tsavo Trust and its partners 38 permanent staff and 23 casual staff were employed generating over \$ 10,000 (Ksh. 1,000,000) of income into Kamungi every month.
- ✓ Community Meetings:
 - ➤ 17th April19 Meeting at TT HQ re further membership registrations.
 - ➤ 22nd April19 Meeting at Nthunguni village with County Govt. MCA, KC CLO, KC members and community members re agricultural best practice etc and HWC / HEC.
- ✓ *Kamungi Membership:* Through a registered CBO KC membership represents 73 families & 730 individuals. This is likely to rise as more people apply (25 families registered in March19).
- ✓ *Kamungi Water Project:* 12,580 litres of water was issued from dispensing kiosk at Ngiluni Village. Several days of no water due to low water table. *Tsavo Trust is looking to other alternatives and funding*.
- ✓ *Ngiluni Dispensary upgrade:* Completed upgrade with power and plumbing. Water remains an issue to deliver going forward. *Tsavo Trust is looking for funding a* 2^{nd} *bore hole here*.
- ✓ *Education:* Tsavo Trust has paid for 2 teachers (1 at Ngiluni & 1 at Kamunyu School within KC) for the last 6 years. This is ongoing.
- ✓ *Training:* Patrick Mutua ongoing training at Bio-Ken Snake Farm, Watamu, for *Snake handling and identification*.
- ✓ *HWC Elephant Bee Fences* 7 x 1-acre bee fences, total 105 bee hives with 10 currently occupied. Due to the poor rains in this area, the bees have not made the honey we had anticipated and in fact many have vacated hives.
- ✓ *HWC* 29 cases were recorded around Kamungi Conservancy this month. HWC cases: 11 elephant cases, 1 lion, 10 Leopard, 7 monkey.
- ✓ *Kamungi Forestry Project* Seedlings have been re planted and ongoing.
- ✓ *Snake anti-venom* Supply for venomous snakes Tsavo Trust partners with the James Ashe Anti-venom Trust (JAAT)/ Bio-Ken Snake Farm, Watamu who are the top-quality anti-venom suppliers. No cases this month. (Tsavo Trust currently holds 4 vials for emergency use).
- ✓ Wildlife Census Transects: Ongoing taking place 2 times per month along set transects within KC to give base line data on wildlife trends. 10 different species were identified this month (88 observations).

Photo below shows the completed Ngiluni Dispensary with elephant paintings (by well-known artist Alexandra Spiratos) on the front wall. It is locally known by community members of Kamungi Cons. as "The Elephant Dispensary". This upgrade was kindly made possible by the Leopardess Foundation.



"SHIRANGO COMMUNITY CONSERVANCY":

- ✓ Ongoing partnership between Tsavo Trust and Shirango Conservancy (SCC) (bordering onto southern boundary of TENP Voi River area). Total area 270km². SCC is located within Kilifi County; Ganze Sub-location; Bamba Ward; Mitangani location; Gede Sub-location.
- ✓ *Employment* Tsavo Trust employs 8 staff from this community including a Community Liaison Officer (CLO) to spear head activities. This equates to over \$ 1,600 (Ksh. 160,000) of income generation every month to this community as a result.
- ✓ Community Meetings:
 - ➤ 8th April19 Chiefs Office to discuss planned water project and Shirango Conservancy
 - ➤ 14th April19 Shirango Village to discuss community engagement in development projects as well as wildlife conservation as it is this avenue that could uplift livelihoods. Gede sub-location community was engaged. Conservancy membership was also discussed.
 - ➤ 18th April19 Shirango Village observing bore hole drilling operation that revealed 2 dry bore holes. Tsavo Trust has brought in the hydrologist again to re survey for water as this project MUST go ahead.
- ✓ Shirango Membership: CBO name change to Shirango Community Conservancy (SCC) is in process and approved by the Board (was Shirango Community Development Project). Draft SCC Constitution is being reviewed now. Members come from 5 villages on the fringes of Shirango Community Conservancy: Shirango; Gede Jira/Garbiti; Ngambo/Baisa; Dabaso; Chamamba. Members registration is ongoing at least 2,000 to date, mainly come from the Watha and Giriama ethnic groups. Ongoing.
- ✓ **Shirango Water Project:** Bore hole drilling rig arrived at the site on 16th April until 25th April. 2 holes were drilled at significant expense, but unfortunately both holes were totally dry. It happens in these arid environments. Tsavo Trust has already completed another hydrological survey and plans for a further bore hole drill are in progress.
- ✓ *Shirango Conservancy land tenure:* Ongoing CLO is regularly following this up in the Kilifi County Govt. offices.
- ✓ *HWC*: There is very significant conflict in Shirango that needs recording: 12 cases recorded: elephant 8; hyena 3, leopard 1.

Photo shows the bore hole drilling rig at Shirango Conservancy on 17th April 2019. Although we have experienced set backs with this water project, Tsavo Trust will continue to achieve the desired results to benefit the Shirango community and through this wildlife protection as well.



Unusual Photo of the Month:

Photo below, taken on 1st April 2019 in TWNP, shows a young elephant calf that clearly has a severed, but well healed, front right leg, essentially, he is a 3-legged elephant. His body condition is fine and when observed further the calf could easily keep up with the herd as they moved through the Tsavo bush. Although this is unusual to see, it does show that even if an elephant loses a leg for one reason or another, there remains a good chance of longer-term survival.
