This photo shows Tsavo Trust's first employee – Mwangangi Koti (TT HQ Foreman & driver) standing by a fibre glass replica mould of the late TWNP well known Tusker called "Kamboyo 1" who passed away in February 2017 of old age.

KWS kindly gave Tsavo Trust permission to make 3 exact replicas in fibre glass of this magnificent elephant (1 set will be donated to KWS TWNP) and this set shown here is on display at Tsavo Trust HO.

Kamboyo was well known to KWS & Tsavo Trust having been first recorded in the Big Tusker data base in March 2013. He had been sighted on average once every 15 days between March13 and Feb17.

WILDLIFE CONSERVATION PROGRAM:

"Big Tusker Project"- aerial and ground mobile teams:

Tsavo Trust's Big Tusker Project (BTP) recorded the following details in the BTP database:

- Total of 20 different individual Tusker's were observed from ground and air coverage.
- 6 bull Super Tuskers 23 different sightings.
- 14 Emerging bull Tuskers 27 sightings.
- Iconic cow Tusker Nil
- \triangleright Total sightings 50.
- ➤ Weather conditions: TT HQ rainfall: 43.5mm. Total rainfall at Tsavo Trust HQ to date: 498mm in 2018.
- **Elephant mortality:** 4 carcasses located (1 fresh, 3 recent): C of D all natural.
- > *Rhino security:* Regular aerial recces in support of KWS over TWNP rhino areas in partnership with ZSL. 6 rhino specific air recces resulted in 2,293km flown over 19 hrs (5 TW & 1 TE).
- > Collared Elephant: Ongoing monitoring from ground and air taking place by KWS / TT teams.



- The locations mentioned above is only an indicator of flight paths taken, many other areas in between are also covered and in so doing providing "eyes in the skies" over Tsavo and directional guidance to ground units.
- All flight paths are logged and recorded with all relevant real-time observations relayed to KWS on a daily basis for their records as well as necessary rapid reaction.
- Map below shows Tsavo Trust's flight paths (2 aircraft) over the TCA in November 2018. The red path is for aircraft 5Y TTZ and the blue for 5Y NRF. 60 hours flown covering 7,179 kilometers over Tsavo in support of KWS: Air & ground activities; Big Tusker monitoring; Locating illegal activities; Wildlife monitoring; Aerial census and tracking.



Field Mobile Units:

Tsavo Trust's mobile field teams work alongside KWS, who take the lead role, on a daily basis. *Tembo 1, 3, 5 teams & Kamungi Scouts* are habitat protection / de-snaring focused whilst *Tembo 2 & 4 teams* are wildlife monitoring based. All teams provide further "eyes and ears on the ground".

COMMUNITY CONSERVANCY PROGRAM:



- ✓ Ongoing partnership between Tsavo Trust and Kamungi Conservancy (KC) (bordering northern boundary of TENP Triangle).
- ✓ *Employment:* Between Tsavo Trust and its partners 38 permanent staff and 23 casual staff were employed generating over \$ 10,000 (Ksh. 1,000,000) of income into Kamungi every month.
- ✓ *Kamungi Water Project:* 22,500 litres of water was issued from the water dispensing kiosk at Ngiluni Village. Each family is rationed to 60 litres per day.
- ✓ **Ngiluni Dispensary upgrade:** This project is in its final stages of completion with roof, water catchment gutters and 2 x 5,000 litre water tanks, verandah, new glass in all windows, re painting inside and out, new ceiling, electric fence around the 3-acre plot. Plumbing, solar electrics and water pipe delivery are in progress. It is planned to be completed by year end.

Photo shows Ngiluni Dispensary upgrade project at the end of November 2018. This total upgrade has been taking place over the last 4 months. The Kamungi Conservancy community members and local Ministry of Health are very grateful. The community are fully aware that the funds raised for this project have come "on the back of wildlife".




- ✓ *HWC Elephant Bee Fences* 7 x 1-acre bee fences, total 105 bee hives with 20 currently occupied. Due to the poor rains in this area, the bees have not made the honey we had anticipated, and so selective harvesting will wait until early 2019.
- ✓ *HWC* 56 cases were recorded around Kamungi Conservancy; mainly leopard killing livestock this month. HWC cases: 12 elephant cases, 4 hyenas, 28 Leopard, 9 lion and 3 zebra.
- ✓ *Kamungi Forestry Project* Seedlings have been re planted and ongoing.
- ✓ **Snake anti-venom** Supply for venomous snakes Tsavo Trust partners with the James Ashe Anti-venom Trust (JAAT)/ Bio-Ken Snake Farm, Watamu who are the top-quality anti-venom suppliers. This month there were no cases attended to in our area of operations. (Tsavo Trust currently holds 4 vials for emergency use).
- ✓ *Wildlife Census Transects*: Set transects have been put in place to cover the core Kamungi Conservancy area and give base line data on wildlife trends. This takes place 2 times per month. 16 different species were identified this month.
- ✓ Community Meetings:
 - ➤ 21st Nov18 Nthunguni Village meeting with M/Andei Chief, KWS & KC CLO re HWC.
 - ➤ 26th Nov18 Nthunguni & Kyusiani villages with County Govt. Chief, KWS, KC CLO again re HWC mitigation measures and options. Elephants being the main concern.

"SHIRANGO CONSERVANCY":

- ✓ **Shirango community engagement** in its early days, but where a growing partnership between Tsavo Trust and the Watha communities of Shirango is fast evolving (although discussions have been ongoing for over 4 years). Through the CLO, employed by Tsavo Trust, this once alienated community is now starting to embrace the "Conservancy" concept and plans are underway to roll out further activities here including a water project (see below), employment (see below).
- ✓ *Employment* Tsavo Trust employs 8 staff from this community including a Community Liaison Officer (CLO) to spear head activities. This equates to over \$ 1,600 (Ksh. 160,000) of income generation every month to this community as a result.
- ✓ Shirango Water Project: Following various meetings, initial phases of a water project (bore hole and solar pump) have taken place. Hydrological surveys took place on 24th and 25th September 2018 and since then EIA has been carried out. We now await NEMA approvals before going. 2 potential sites were located, as we await the final report. Once this is in hand applications for EIA and NEMA and local County Govt. approvals before going ahead. This project is being implemented to assist local people who have historically lived off elephants, bushmeat and other natural resources from the TENP, but now have an understanding that this water has come to them "from the elephants" and as a result it is hoped that with engagement with the Watha people here, elephant poaching and bushmeat will significantly reduce.
- ✓ Community Meetings:
 - ➤ 20th Nov18 Shirango meeting re bore hole Environmental Impact Assessment (EIA) for National Environment Management Agency (NEMA).

This aerial photo of the young Shirango Conservancy, bordering onto TENP southern boundary, clearly shows the potential for community participation in wildlife conservation activities given the intact habitat, the fact it borders the TENP and the keen interest that the Watha people of this area have displayed in their engagement with Tsavo Trust to take this project forward. To add to this, Shirango could become a very meaningful protective buffer in support of KWS along this once troubled boarder of the Park.



Unusual Photo of the Month:

Aerial photo shows a critically endangered (IUCN Red Listed) White Headed vulture (Trigonoceps Occopitalis) in TENP on 2nd November 2018. Tsavo Trust is taking an active role on documenting endangered raptors as we carry out aerial patrols in support to KWS over TCA.
