
13<sup>th</sup> November 2021: Photo shows the desperate effects of the recent drought that hit many parts of Kenya, including Tsavo.

This poor giraffe died in a driedout water hole in TWNP, just 2 weeks before the rains fell. Such is the harshness and reality of nature.



#### Aerial Reconnaissance and Ground Patrols - Areas Covered:

- Aerial patrolling is a vital conservation tool providing "eyes in the skies" and directional guidance to ground units who provide "eyes and ears" on the ground. The combination of both is effective.
- All flight paths and ground patrols are carried out jointly KWS/TT and recorded with all relevant real-time observations relayed to KWS daily for rapid actions and for their records.



Map shows Tsavo Trust's flight paths in RED and ground patrol paths in GREEN over the TCA this month.

Note: The Tsavo Parks are huge comprising 22,000km<sup>2</sup> (TENP, TWNP & CHNP) and then a further 20,000km<sup>2</sup> totaling 42,000km<sup>2</sup> to form the Tsavo Conservation Area (TCA).

**Aerial:** 50.5 hours flown covering 6,299 kilometers over Tsavo in support of KWS.

**Ground:** 952 kilometers of foot patrol and a further 16,534 kilometers of vehicle patrol in Tsavo to support KWS.

Activities cover: Air & ground security patrols; Big Tusker monitoring; Rhino related activities; Locating illegal activities; Wildlife monitoring; Aerial census and telemetry tracking as well as Community Conservancy aerial and ground activities.



November 2021: Photo shows one of the Tsavo black rhinos having an evening nap. This population is heavily guarded by KWS in the NRS as well as those outside in the IPZ.

Tsavo Trust and partners Zoological Society of London (ZSL) play a significant role in supporting KWS within Tsavo's rhino ranges, as reliable partners.

## Field Mobile Units:

Tembo 1, 3, 5, 7 teams, Kamungi & Shirango Scouts are habitat protection / de-snaring focused.

Tembo 2 (TENP) & 4 (TWNP) teams are wildlife monitoring dedicated.

All teams work alongside KWS daily and provide further "eyes and ears in the field".

#### **Bushmeat poaching – November 2021:**



Left: 23<sup>rd</sup> November 2021 – following an informer tip off, in an aera outside of TENP, joint KWS/TT teams recovered 63kg dried bushmeat, consisting of: 1 Grants gazelle, 1 young lesser kudu, 12 Dikdiks. Various poaching equipment was recovered including small and medium sized snares, cooking equipment, 2 bicycle, 2 lamping torches etc. 1 arrest was also made.



**Above:** 10<sup>th</sup> November 2021 – Giriama Ranch outside TENP. This unusual bushmeat recovery of a porcupine (with main quills removed) along with other poaching equipment (snares, 1 bicycle). It clearly demonstrates the desperation by communities in remote areas where livelihood options are very inadequate, if any at all, and so one of the few remaining options is illegal bushmeat poaching for subsistence to survive.

<u>Note:</u> By no means is all bushmeat poaching for subsistence, there are many cases of large-scale commercial poaching as well.

**Right:** 1<sup>st</sup> November 2021 – photo taken from inside a bushmeat poachers hide out, outside of TENP, Shirango, showing dried bushmeat hanging from branches inside the hideout.

At least 7,000 community members stand to benefit from this project.

**Below:** Photo shows the 2 strands of wire, 5 foot off the ground (allowing passage of livestock underneath) and the 3<sup>rd</sup> wire is the earth, set underground. This fence configuration is a tried and tested HEC mitigation system that has worked well.

#### Unusual Photo of the Month:



14<sup>th</sup> November 2021: photo shows a rarely seen Striped hyaena (Hyaena hyaena) in TENP. What is unusual about this photo is that it was taken during the late morning and normally by this time, these nocturnal creatures are deep in their burrows or dark caves. They are not uncommon, just not commonly viewed at close range given their shyness.
