Since the 1st of March 2023, Tsavo Trust has been involved in the 2023 Tsavo Lion Survey alongside the Wildlife and Research Training Institute (WRTI). The aim of the activity is to determine the current Tsavo lion population. The last Tsavo Survey of 2019 had estimated the lion population to be 460.





Aerial Reconnaissance and Ground Patrols - Areas Covered:

- Aerial patrolling is a vital conservation tool providing “*eyes in the skies*” and directional guidance to ground units who provide “*eyes and ears*” on the ground. The combination of both is effective.
- All aerial patrols and ground patrols are carried out jointly - KWS/TT and recorded with all relevant real-time observations relayed to KWS daily for rapid actions and for their records.

TSAVO TRUSTS AERIAL AND GROUND PATROLS COVERAGE
APRIL, 2023



The map shows Tsavo Trust's flight paths in RED and ground patrol paths in GREEN over the TCA this month.

Note: The Tsavo Parks are huge comprising 22,000km² (TENP, TWNP & CHNP) and then a further 20,000km² totaling 42,000km² to form the Tsavo Conservation Area (TCA).

Aerial: 43 hours flown covering 5,311 kilometers over Tsavo in support of KWS.

Ground: 988 kilometers of foot patrol and a further 22,811 kilometers of vehicle patrol in Tsavo to support KWS.

Activities covered: Air & ground security patrols; Big Tusker monitoring; Rhino related activities; Locating illegal activities; Wildlife monitoring; Aerial census & telemetry tracking & Community Conservancy aerial and ground activities.

Unusual Photo of the Month:



The photo above shows an elephant poacher arrested by a joint KWS/TT team. This poacher had been on the KWS/TT wanted list for 4 years. The poacher was arrested with 2 fresh elephant tusks that he had poached 2 weeks before his arrest. A bow and 15 arrows laced with poison, and 10 grams of poison were also recovered. The arrest was made possible by intelligence gathered from the local community. Evidently, local communities will support conservation efforts if they are recognized and engaged as nature custodians.
