

The photo above shows Tsavo Trust handing over the upgraded Nthunguni Dispensary in Kamungi Conservancy, in a ceremony presided over by the Deputy Governor of Makueni County. The upgrade delivered improved infrastructure, water and sanitation systems, and essential medical equipment, significantly enhancing service delivery for local households. Tsavo Trust also provided additional medical equipment to both Nthunguni and Ngiluni Dispensaries, further strengthening basic diagnostic and maternal health services across the community.

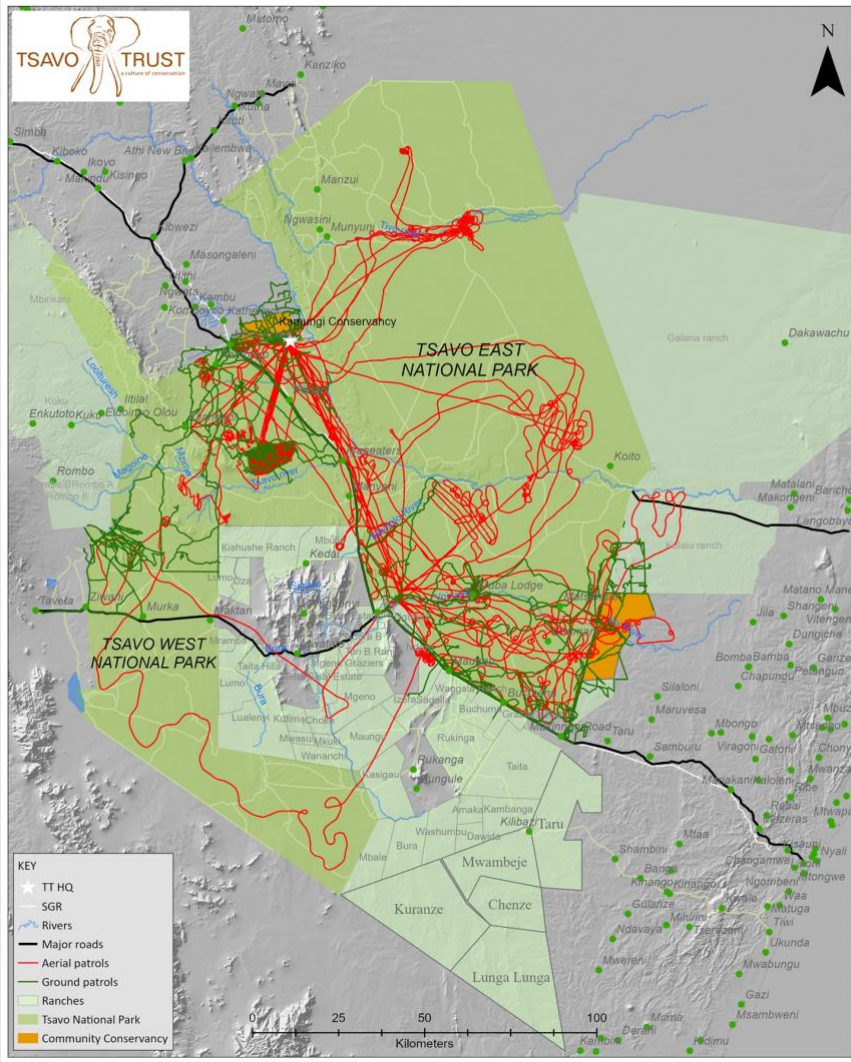

Aerial Reconnaissance and Ground Patrols - Areas Covered:

- Aerial patrols are a vital conservation tool providing “**eyes in the skies**” and directional guidance to ground units who provide “**eyes and ears**” on the ground. The combination of both is effective.
- All aerial patrols and ground patrols are carried out jointly - KWS/TT and recorded with all relevant real-time observations relayed to KWS daily for rapid actions and for their records.

**TSAVO TRUST'S AERIAL AND GROUND PATROLS COVERAGE IN TCA
November, 2025**



*The map shows Tsavo Trust's flight paths in **RED** and ground patrol paths in **GREEN** over the TCA this month.*

Note: The Tsavo Parks are huge comprising 22,000km² (TENP, TWNP & CHNP) and then a further 20,000km² totaling 42,000km² to form the Tsavo Conservation Area (TCA).

***Aerial:** 72 hours flown covering 9,921 kilometers over Tsavo in support of KWS.*

***Ground:** 1,184 kilometers of foot patrol and a further 25,318 kilometers of vehicle patrol in Tsavo to support KWS.*

Activities covered: Air & ground security patrols; Big Tusker monitoring; rhino related activities; large carnivore monitoring; locating illegal activities; wildlife monitoring; aerial census & telemetry tracking & Community Conservancy aerial and ground activities.

The Photo below shows the Kamungi Conservancy Chairperson addressing Kajire community members and STE representatives during a benchmarking visit to Kamungi Conservancy. The group learned from Kamungi's governance, conservation initiatives, and livelihood projects, and toured key sites including the 10% fence plan, Ngiluni Dispensary, and Kamungi Bandas.



Field Mobile Units:

Tembo 1, 3, 5, 7, 9, 11 teams, Kamungi Scouts are habitat protection / de-snaring focused.

Tembo 2 (TENP) & 4 (TWNP) teams are wildlife monitoring dedicated.

Tembo 6, 8 & 10 (TWNP) teams are rhino specific with confidential info.

All teams work alongside KWS / WRTI daily, providing further “eyes and ears in the field”.

These interventions support individual identification and real-time monitoring ahead of the planned partial fence drop at Ngulia Rhino Sanctuary, TWNP.

The team confirmed that household electric fences are operating as intended. ➤ 13/11/2025: Hosted 46 Kajire community members and STE representatives for a benchmarking visit on establishing a community conservancy. The group learned from Kamungi's governance, conservation work, and livelihood projects and toured key sites, including the 10% fence plan, Ngiluni Dispensary, and Kamungi Bandas. ➤ 26/11/2025: Participated in a beekeeping training session in Nthunguni, facilitated by the World Food Programme. The training targeted farmers selected by the Office of the Assistant Chief. ➤ 27/11/2025: Kamungi Conservancy held its AGM at the Ngiluni water tank, attended by 188 members and partners, including KWS, Makueni County, the National Government, and Tsavo Trust. The AGM provided an opportunity to review progress, strengthen governance, and set priorities for the coming year.
Membership	Through a registered CBO and Not for Profit Company Limited by Guarantee, governed by an elected Board, KC membership represents 505 families & over 5,050 individuals from 13 villages, mainly from the WaKamba community.
Water Project	110,700 litres issued at Ngiluni Water Tanks. Additionally, TT provided 110 dam liners and 28 water tanks. (1,216,420 litres for the year to date) Ngiluni Primary School connected to piped water.
